- A. Systems Academic (formerly SAPC). No report.
- B. General Education Committee. Met November 28th and December 9th. The remainder of the courses with a May 2014 sunset date were submitted by the departments and reviewed by the Committee. Two courses were not approved for renewal. In addition to the sunset renewals, Exploring Grammar, which changed from four to three credits, lost its SIDI status. The Committee used a Moodle page to organize all materials and have them available to the members, e.g., proposals for renewal or initial Gen Ed status. It worked very well and made it easier to keep track of everything. Minutes are also posted there. The Committee will have a retreat in January to discuss assessment of the program.
- C. Council of Educator Preparation. Did not meet in December. They will have a retreat on January 7th.
- D. Steering Committee. The Speaker-Elect has issued two calls for volunteers to serve on the three new taskforces created by the Provost. We need a reporting tool for assessment data, an ability to run reports and share data. The Steering Committee will meet in January; topics include Faculty By-laws.

- B. Review of dean-updated Curriculum Committee forms. Liz reported that the Provost is still working on the forms; they are not yet ready for the Committee.
- A. Requesting/requiring syllabi for courses which change level (to/from 2000 to 3000-level, for example). Should we require a new syllabus? What make a course a 2000 level or 3000 level? Can you see on the syllabus the 2000-ness or the 3000-ness? What do you look for? Perhaps we would see patterns when we compare syllabi. Motion: A new syllabus should accompany a Curriculum Change proposal when the level of a course is changing upward (e.g., 1000 to 2000, 2000 level to 3000, 3000 level to 4000). *Approved 5-0-3-3.*

The meeting adjourned at 4:00 pm.
