The only aid available for summer semester is Pell Grant, Federal Work-Study, Federal Direct Loans, Federal Parent PLUS Loans, or Alternative Education Loans.

**To be considered for summer financial aid you must:**

- Completed the Free Application for Financial Aid (FAFSA) for the 2021-2022 academic year.
- Completed all outstanding financial aid requirements.
- Have paid all prior academic year balances owed on your student account.
- Be enrolled in at least 6 credits to be eligible for Federal Direct Loans during the summer term.  
Be enrolled in at least 3 credits to be eligible for Federal Pell Grant during the summer term.
- Complete the summer aid application at least 2 weeks prior to the end of your last summer courses end date. Applications received after you are no longer actively attending a summer course will not be processed.
- Be meeting the [Satisfactory Academic Progress policy guidelines](#) as outlined on the PSU Financial Aid website under "PSU Policies."

**Important Information to Know Regarding Aid for Summer:**

- Federal aid will not be disbursed until *after* July 1 *and* the start of all Summer Courses you are enrolled in have begun.
- Federal Direct Student loans are divided evenly over the number of terms you are enrolled during the academic year. The federal annual maximum loan amount remains the same regardless of the number of terms you are enrolled (unless it's your final semester, in which case loans are pro-rated).
- For students enrolled in at least 6 credits: Parents may consider a Federal Direct PLUS loan or students may apply for a private alternative loan.
- For students receiving free PSU Housing during summer: this will decrease allowable expenses for PSU Housing Cost
